ATM Service

The information in this section and any further instructions and conditions that may be prescribed by the Bank from time to time are the terms of the agreement between you and National Investment Bank Limited. These terms are binding when you sign and take delivery of your Cash Link ATM Card.

I/We hereby agree to be bound by the following terms and Conditions with respect to the following:

1. That at all times that this ATM card is the property of National Investment Bank Limited and consent to surrender it totally and without reluctance when asked to do so by the Bank
2. Only use the Card when there are adequate funds in the account to cover the transaction.
3. That all rights and responsibilities under this service are not transferable.
4. That the use of the Card shall be limited only to the authorized Card Holder to whom the Bank has issued the card.
5. That the card shall not be used after notification of its cancellation or withdrawal by the Bank.

6. That the Personal Identification Number will not be disclosed, nor written on the card and kept with the card.
7. That the Bank shall be notified immediately of the loss or theft of the card, failing which the authorized Card Holder will be solely liable for any loss arising from unauthorized use of the card and PIN.
8. Replacement of Cards & PINS would attract a fee.
9. That the authorized Card Holder will accept full responsibility of all ATM transactions except after the Bank has been notified of the loss or theft of the card.
10. That the Bank's record of all ATM transactions are conclusive and binding and that the bank be authorized to debit account as a result.
11. That the Bank shall not be held liable or accountable for any loss or injury caused by any faulty or mechanical flaw or funds shortage.
12. That all risks relating to the use of the card shall be borne by the authorized Card Holder.
13. That National Investment Bank Limited will not be held responsible in any way for a dishonoured card.
14. That the authorized Card Holder shall return the card for cancellation should it be required or in event of the Account being closed.
15. That the Bank has the right to terminate the ATM service at any given time without prior notice either by card cancellation or renewal refusal.
16. That the Bank is entitled to change these Terms and Conditions without giving a prior notice in writing to customers.
